## CALL FOR MEMBERS OF THE FINANCIAL CONTROL COMMITTEE

### DEADLINE EXTENDED

Deadline is extended to August 9th, 23:59, for candidates who self-identify as women, trans or genderqueer

The Financial Control Committee (FCC) is responsible for the internal control of the FYEG finances. The FCC consists of 2 individuals, who meet in Brussels once or twice a year to check the FYEG finances. Their mandate is of two years.

The current members are Tornike Kusiani (elected in 2019 - his term continues until 2021) and Laura Krenzke-Wohlfart (elected in 2018, her term ends in 2020). We are therefore looking for candidates to fill one seat in the Financial Control Committee.

We accept candidacies of people self-identify as woman, trans or genderqueer.

### REQUIREMENTS

#### The FCC tasks include:

- Two in-person meetings per year, dedicated to checking FYEG's finances. The FCC should also verify the adequacy of the expenses and the congruence of the expenses with the resolutions taken by the EC and the general assembly.
- A written report must be submitted, thereby

providing an internal audit.

- The presentation of this yearly report to the delegates at the GA.

#### Profile of a candidate:

- Experience with NGO finances.
- A working knowledge of English language (written and oral) is necessary.
- No financial or professional state of dependence towards FYEG.
- Knowledge of FYEG and understanding of its financial situation.
- Experience with EU funding, financial administration and/or financial management and Belgian legislation is a big advantage.

These positions are voluntary, so please note that the positions are unpaid. But presence at the FCC meeting will be fully reimbursed.

## APPLICATIONS

Applications should contain a motivation letter, explaining how you fit to the profile above.. Applications should be sent to [office@fyeg.org](mailto:office@fyeg.org).

Please bear in mind that your CV and your motivation letter will be publicly available on FYEG website, to all MOs and delegates at the GA.
