TRANSITIONAL STATUTE

ARTICLE 1 - BELIEFS

- 1. Giovani Europeisti Verdi (GEV) has sustainable, rightful, peaceful, inclusive Europe as its political horizon. The key beliefs of Giovani Europeisti Verdi are the ones laid down in the Mission Statement of GEV (Appendix 1).
- 2. Giovani Europeisti Verdi is a no-profit organisation. All the positions inside the organisation are pro bono.

ARTICLE 2 - REGISTRATION

- 1. Young people between the age of 16 and 35 can register to Giovani Europeisti Verdi, in respect of equal opportunities and equal dignity.
- 2. The registration implies full acceptance of the Statute of Giovani Europeisti Verdi.
- 3. The registration to Giovani Europeisti Verdi is incompatible with the membership of any other partisan-political association or organization, except Federazione dei Verdi and Europa Verde.

ARTICLE 3 - BODIES

- 1. The political leadership and governing bodies of Giovani Europeisti Verdi are: the Congress Assembly, the National Council, the Warranty College, the Executive Board, the Treasurer and the two Co-Spokespersons (which will have necessarily to be of different gender).
- 2. The bodies described here in reference to national level are equally reproduced, except the Warranty College, at regional and provincial level, consistent with the number of members and the respective raison d'être.
- 3. All the bodies of Giovani Europeisti Verdi guarantee, always, equal gender representation.
- 4. If, on a local or regional level, equal gender representation would prove to be impossible at the time of constitution of the bodies, it would be possible to constitute them anyway, though preserving, for each of the bodies, a number of seats for the underrepresented gender, equal to the difference between the seats held by people belonging to the overrepresented gender and the ones held by the underrepresented gender.

ARTICLE 4 - THE NATIONAL COUNCIL

- 1. The Council is the political steering body for Giovani Europeisti Verdi. It is composed of 70 members, elected by the National Congress.
- 2. The Council nominates the Executive Board from among its members.
- 3. The Co-Spokespersons are members of the National Council by right.
- 4. The Council's resolutions are adopted by majority of its members. The only exceptions to simple majority consist in amendments to the regulations or to the congressional provisions, which require a 2/3 majority.

5. The Council may appoint a secretary, with the task of compiling the minutes of meetings.

ARTICLE 5 - THE WARRANTY COLLEGE

- The Warranty College is elected inside the National Council and it is composed of 7 members. It is in charge of ensuring the application and enforcement of regulations and guidelines that have emerged in the activity of the bodies of Giovani Europeisti Verdi.
- 2. The Warranty College recognizes, among its members, a president, who organizes and moderates its activities, and a secretary, in charge of compiling the minutes of meetings and to hand them over to the Treasurer.
- 3. The term of the Warranty College lasts 3 years.

ARTICLE 6 - THE EXECUTIVE BOARD

- 1. The Executive Board is the national collegiate body and it is composed of 15 persons elected by the National Council.
- 2. The two Co-Spokespersons, are part of the Executive Board, convene it and preside over it.
- 3. The Executive Board is responsible for implementing the programme and the policy of Giovani Europeisti Verdi.
- 4. The Executive Board is responsible for the political organization and administration of Giovani Europeisti Verdi.
- 5. The Executive Board nominates the Treasurer among its members.

ARTICLE 7 - THE TREASURER

- 1. The Treasurer is elected by the Executive Board, among its members.
- 2. The Treasurer is responsible for the budgetary management and the enrollment for Giovani Europeisti Verdi.
- 3. The Treasurer is also responsible for the conservation of the minutes of the meetings of the National Council of Giovani Europeisti Verdi.

ARTICLE 8 - THE CO-SPOKESPERSONS

- 1. The two Co-Spokespersons are elected by the Congress Assembly, in accordance with the principle of gender equity.
- 2. The two Co-Spokespersons represent Giovani Europeisti Verdi. They are part of the Executive Board and preside over its work by right.

TRANSITORIAL AND FINAL PROVISIONS

 The present Statute is transitional and valid until the National Congress to be convened, concurrently with the National Congress of Europa Verde, as soon as the Covid-19 emergency is over.

- 2. Article 4, paragraph 1 does not apply until the National Congress. During the transitional phase the Council is considered to be composed of every person eligible to vote in the Constitutional Assembly.
- 3. Article 5 of this regulation does not apply until the National Congress.
- 4. Giovani Europeisti Verdi will join Europa Verde in the latters' National Congress, as its youth organization.
- 5. We GEV are open to possible alliances and twinships with other forces and political associations, both national and supranational, that identify themselves with the values exposed in our Mission Statement.
